

**Webster Bank Big Goals Bracket Sweepstakes ("Sweepstakes")  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED. U.S. LAW GOVERNS THIS PROMOTION.**

**1. Eligibility:** The Sweepstakes is open to legal residents of Connecticut, Rhode Island, Massachusetts, and New York who are eighteen (18) years of age or older at the time of entry. Employees, officers & directors of Webster Bank ("Sponsor"), Adams & Knight, Inc., teamDigital Promotions, Inc. Additional entries received from the same person/email address in excess of the stated limitation will be void. The name of the authorized account holder associated with any given email address will be deemed to be the entrant and must comply with these Official Rules. The authorized account holder is defined as the natural person who is assigned an email address by an internet access provider, an online service provider or another organization that is responsible for assigning email addresses or the domain associated with the submitted email address. Proof (to Sponsor's satisfaction) of being the authorized account holder may be required by Sponsor. Winner Selection/ Notification:** At the conclusion of the Promotion Period, one (1) Grand Prize winner will be randomly selected from among all eligible entries received throughout the Promotion Period. Drawing will be conducted by Administrator on/about 4/1/24. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. The potential winner will be notified by telephone and/or email and will be required to execute and return an Affidavit of Eligibility, Liability and (where legal) Publicity Release and any other required documentation within twenty-four hours of time of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of the prize to an alternate winner.
